### Surprise, Surprise!

#### 2023 did not turn out the way we planned.

or 2023, OPAL's plan was to start construction on 10 new ownership homes on Kidder Way. That didn't happen, as the County's Permit Department is woefully understaffed, and as of this writing still has not released the land use or building permits.

OPAL's plan at the beginning of 2023 did not include the crescendo that occurred in December with the purchase of the 11.3-acre property on Pea Patch Lane. And OPAL's plan certainly did not include saying farewell to five staff members – significant turnover for an organization with nine employees.

Despite the delays on Kidder Way's construction, there were so many other wonderful accomplishments that you made possible:

- The renovation of Northern Heights is complete and the 12 one-bedroom apartments are fully occupied.
- The renovation of two of the three buildings at the Mt. Baker Apartments is complete and all the renters who lived there before OPAL purchased the property have moved back into their newly refurbished and much more energy-efficient apartments.
- Through a collaboration with the Community
  Foundation, Community Resource Center and
  the Food Bank, islanders donated nearly all that
  was needed to purchase property on Pea Patch

Lane for an integrated campus including more rental housing and facilities for the Food Bank and Community Resource Center.

In addition, here are some numbers pertaining to OPAL's ongoing work:

- 2 OPAL homeowners sold their homes at an affordable price to new families who now have stable housing;
- 6 households were borrowers from the Island Loan Fund;
- 9 OPAL homeowners utilized OPAL's project management to either paint or roof their house;
- 32 households participated in housing counseling or homebuyer education.
